HUNTING RULES

Hunting is subordinate to the conservation of nature and only one method of sustainable utilization. It is important not to damage the environment and to always interact sensitively with nature. Therefore it can be enjoyed but accuracy in your shooting must always enjoy the highest priority.

1. Every hunter has to perform an accuracy test before he will be allowed to hunt. The test will require an accuracy of 100% with an 8" grouping around the centre off the target with 4 arrows from a 30m distance.
2. Blinds are not allowed to be left for 30 minutes after a shot has been taken or if there are any animals in sight. Preferably the hunter has to wait inside the hide until a pick-up vehicle or support arrives.
3. The Hunter undertakes to declare all shots
4. The Hunter is responsible to have proper and suitable equipment to ensure a proper shot.
5. A limited number of marked arrows will be allowed during the hunt. A maximum of 4 marked arrows and NO bow carry bag will be allowed to be taken to the blinds.
6. Arrows will be inspected by the farm representative during pick-up or immediately after the hunt.
7. The hunter has to inform the representative of his whereabouts if he is walking by himself.
8. A representative of the farm must always be aware of the location of the hunter.
9. The use of intoxicating liquor during the hunt is not permitted.
10. No refuse may be discarded in the hunting field or in the camp.
11. Should a hunter wound an animal without finding it, they will still be held responsible for the full payment thereof.
12. Only the hunter, and not the guide or 'Rugania Game Park', is responsible for the size, sex and huntability of the game he hunts. The hunter must therefore take care to only shoot game he intended to hunt.
13. Do not shoot over border lines
14. Be very careful with matches, etc. >> Please do not start veld fires.
15. Any hunters who damage the property or any item on the property will be held responsible for the cost of damage done.
16. Hunters are requested to wear Khaki or suitable camouflage clothing while hunting.
17. As soon as an animal is shot, the hunter takes on ownership and responsibility.
18. There will be no discount given should a small animal or trophy be shot.
19. A parent and a guide must accompany children under the age of 18.
20. The owner or the staff will not be held responsible for any loss, theft or damage of personal belongings.
21. All guests shall strictly adhere to weapon safety rules if they have any in their possession.
22. Hunters & Visitors visit at their own risk.
23. Any person who does not comply with these rules will be expelled from the hunting area or facility with NO refund on deposits already paid by such a person.



INDEMNITY FORM

I, the undersigned with ID number hereby undertake on my behalf or on behalf of a minor child in my care to sign the rules and undertake to adhere to all the rules and regulations of Rugania Game Park.

I indemnify the owner, manager and any personnel including all service providers (Hereafter referred to as Rugania) on behalf of myself and any minor child in my care, of any claim, damage, actions or reasons for actions which could result in claim, injury or damage to me as a person or property during my visit or participation in any activity at Rugania even if the loss, injury or damage is directly or indirectly caused due to negligence of Rugania.

I admit that the pleasure that nature provide are accompanied with its own dangers and risks and indemnify Rugania of any such claim, injury or damage to me as a person or property. I am fully aware and acknowledge the risks and dangers involved in the activities offered at Rugania and accept the use of any facility, equipment, transport and accomodation is at own risk.

In the case where I might require medical or hospital treatment I authorize Rugania to act in their own discretion to obtain such medical assistance and such cost will be fully for my account.

This indemnity is bounded on any estates, heirs, executors, administrators, trustees, assigns, liquidators, curators or other legal representative of the parties as fully and effectually as if they had signed this agreement in the first instance and reference to any party shall be deemed to include such party's estate, heirs, executors, administrators, trustees, assigns, liquidators, curators or other legal representatives as the case may be.
